LIABILITY RELEASE:

I, as owner and/or exhibitor am entering this show/event voluntarily and at my own risk, and assume all responsibility for loss. I, for myself, representatives, agents, successors and assigns release, discharge, and waive any and all rights to sue or make any claim against **MOTOEXPO** and any or all affiliated sponsors or advertisers, the 22nd District Agricultural Association owner of the venue, the officers, officials, directors, shareholders, agents representatives, assigns, staff and/or employees of Released Parties from all liability, demands, judgments, claims, loses, including attorneys fees and possible causes of action that may otherwise accrue from any loss, injury or death to my person, lost, stolen, or damaged property, including, but not limited to, personal effects or belongings, supplies, equipment,

display(s), exhibit(s), trailer(s), motorcycle(s), and/or vehicle(s), or any part thereof, from any cause, resulting from or arising in connection with, or related to this show without limitation, whether or not attributable to my own negligence or conduct or to the fullest extent permitted by law, or that of the Released Parties. Further, I expressly agree to indemnify all the Released Parties from any and all liability occasioned or resulting from the conduct of spectators, exhibitors, or any personnel assisting, and/or accompanying me at the show under my direction and control. Furthermore, I agree to reimburse **MOTOEXPO** and Released Parties all costs to those persons or organizations connected with this event for damages incurred as a result of my negligence.

PUBLICITY, ADVERTISING & COMMERCIAL RELEASE:

In consideration of this entry, I, as owner and/or exhibitor agree to permit **MOTOEXPO** and Released Parties, the right to use my and/or their names and pictures of such persons and entered exhibit(s) (displays and/or motorcycles) and person(s) for publicity, advertising, and commercial purposes, in any format (including newspapers, magazines, radio, television, videos, and the Internet) before, during, and after the show, and relinquish any rights whatsoever

MOTOEXPO reserves the right to accept or refuse any application for the show. **MOTOEXPO** and/or the chief show judge reserves the right to prohibit entry, remove, or disqualify any exhibit (display and/or motorcycle) or part thereof, or any owner/exhibitor from the show, that or who, does not abide by the rules and regulations, or in **MOTOEXPO's** opinion, the entry is deemed not show worthy and/or inappropriate, or detracts from the integrity or is not in the best interest of the show. Exhibitors/entries removed from the show under these circumstances will not be eligible for trophies, cash awards, or other premiums and may result in forfeiture of entry fees and/or denial of future applications

for show. In addition, **MOTOEXPO** will have final authority in determining the location of exhibitor's entry/display within the show and will not allow the removal of same prior to end of the show. Exhibitors are expected to keep their motorcycles uncovered and displays intact during show hours. Any dispute over the application or interpretation of rules will be solely determined by the **MOTOEXPO** and /or the chief show judge—and their decision(s) will be final. All registration, classing, judging, award, and ballot count forms are for the private use of **MOTOEXPO**, bike show judges, and support staff. Show paperwork is not available for public or exhibitor viewing and/or possession. ALL bike show paperwork is and remains the property of **MOTOEXPO**.

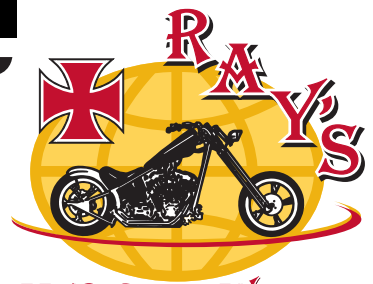

NOTE: A "full custom" classification usually constitutes use of an altered frame (as described above under Frame Critique), an after-market frame of other than stock dimensions, or a frame of homemade construction. Antique (pre-1957) implies all motorcycles (stock or custom), excluding H-D Knucklehead and Panhead models. Evo & Twin Cam Sport Bagger Class - an H-D Road King model would be an example of a motorcycle in this class. Sport Street Class implies "crotch rockets" (of all makes), plus Harley-Davidson/Buell. NOTE: Stock Harley-Davidson Evolution and Twin Cam models are discouraged from entering show competition.

IMPORTANT NOTE: Pre-registered & prepaid applications must be received by Thursday, September 17, 2008.

ALL BIKE SHOW SET UP IS ON FRIDAY ONLY, SEPTEMBER 26, 2008 from 9:00 AM to 7:00 PM. Bike show identification cards must be posted and exhibitors out of the building by the close of set up hours as judging immediately begins at 7:00 PM.

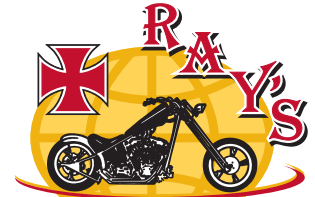
